

# WHAT TO DO IN CASE OF AN ACCIDENT

- See a doctor immediately. Although you may feel fine now or think your injuries aren't very serious, symptoms can appear days after the accident.
- Take photos of your car's damage.
- Call police, remain at the scene and write down any information from witnesses at the scene of the accident, with names and addresses.
- Schedule a physical exam as soon as possible. You could have injuries that could not affect you until later on.
- Don't sign release forms or checks with releases on them before you're ready to settle completely
- Keep in contact with the insurance companies or adjusters regarding how you feel each day.
- Consult with us for help with injuries.
- Pay nothing or promise nothing to any party without consulting with your lawyer first.


